Neighborhood of the Week: Central Business District and Downtown Denver

Downtown Denver is considered an outdoor walkable area that offers attractions for everyone's enjoyment. There is an endless supply of restaurants (many with outdoor seating), shops, museums, art galleries, beautiful hotels, the convention center, sports arenas, coffee shops, boutiques, bars and innovative craft breweries to name a few choices. The Denver Beer Trail is a great guide to sampling those local brews. Over the years many of the original Downtown structures have been removed to make way for new construction. However, a few have been preserved with the aid of the Denver City Council when they approved the Denver Landmark Preservation Ordinance in March 1967. This was a year after the National Historic Preservation Act was enacted and two years after Dana Crawford began creating Larimer Square. A walk or a drive through Downtown Denver will give you a good idea of the remaining structures that have been repurposed over the years.

Another renovation and reuse building plan was Denver Union Station. It's a large-scale mixed-use development in Downtown Denver which includes office, residential, retail, hotel and transit uses. The project integrated 14 previously nonexistent blocks between Riverfront Park and the previous edge of downtown, into an inviting urban center.

As with most major cities, the Denver Skyline is home to several notable office and residential buildings. The city went through a large building boom that lasted from the early 1970s to the mid-1980s. During this time, 21 of the city's 27 tallest buildings were designed and constructed, including Republic Plaza, 1801 California Street, and the Wells Fargo Center, which is nicknamed "The Cash Register" because of its unique crown.
