## What Should You Do Immediately After a Car Accident?



The first thing to do after a car accident is to determine whether there are injuries and seek immediate medical treatment. Law enforcement should be contacted, and if you are able, you should take photographs of the scene of the accident, as well as obtain witness addresses and contact information, when possible. Once you are home, contact your own insurance company, but offer only the basic facts until you have spoken with a personal injury attorney to discuss your options. Keep careful records of your injuries, your treatments, your medical expenses, and notes of everything you remember about the accident.

Stick to the facts if you are questioned by the police following an accident. If you don't know the answer to a question, say so—you never want a statement you made in the chaos of an accident to haunt you later. Never, ever, say "I'm sorry." Unfortunately, even if you are simply saying you are sorry the accident occurred, it can be misconstrued as an admission of guilt.

Be very careful on social media when talking about the car accident and be wary of early settlement offers from your insurance company. It is always a good idea to speak with, and hire, an experienced Colorado car accident attorney as quickly as possible. ## No Bake Pumpkin Cheesecake

### Ingredients

- 16 Biscoff cookies, crushed into crumbs, leave extra for topping
- 3 tbsp of unsalted butter, melted
- 1 (8 oz) package of cream cheese, softened
- 1/2 cup of powdered sugar
- 3/4 cup canned pumpkin puree
- 1 tsp of pure vanilla extract
- 2 1/2 tsps of pumpkin spice extract
- 1 (8 oz) tub of frozen whipped topping, thawed (TruWhip or Cool Whip)



### Directions

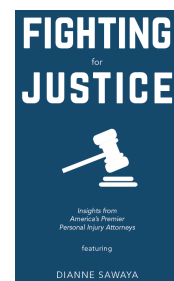
1. In a medium bowl, stir together the Biscoff cookie crumbs and melted butter. Evenly divide the crumbs between 8 individual serving dishes (about 2 1/2 tablespoons per dish) and press into the bottoms of the dishes to form a crust layer.
2. In a large bowl, with an electric mixer, beat the cream cheese and powdered sugar on medium-high speed until smooth and creamy. Add in pumpkin puree, vanilla, and pumpkin pie spice and mix until fully incorporated. Using a rubber spatula, fold in the whipped topping until well blended and no streaks remain.
3. Evenly pipe or spoon the filling into individual serving dishes, about 1/3 cup of filling per dish. Cover with plastic wrap and refrigerate for at least 3 hours before serving.
4. If desired, garnish with additional whipped topping and Biscoff cookie crumbs before serving. (Yields 8 servings)
