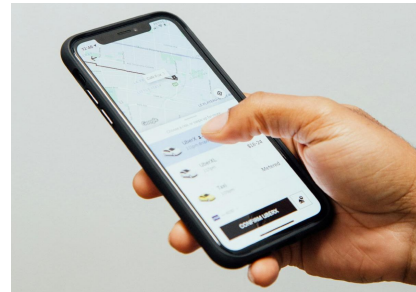

What Should I Do After an Uber or Lyft Accident?



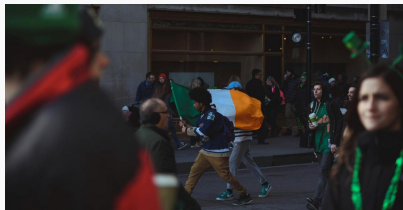
Just as you would do with an accident in your own vehicle, as a passenger in a Lyft vehicle, you should ensure that the police are notified. It is always important to have a police report when establishing liability for injuries and other damage. A police report can be particularly helpful in protecting your legal rights when you must prove that—as a passenger—you were uninvolved with the actual cause of the accident. Everyone involved in the Lyft accident must seek medical attention immediately—even if you are uncertain whether you have suffered injuries. Having a medical professional check you out following an accident will protect your interests and strengthen your case.

It is also extremely important to document the accident whenever possible. Many insurance companies—and attorneys—use photos and videos as the primary form of evidence in an auto accident claim. If you are able, take photos at the scene

of the accident, including all those involved, and the vehicles involved. If there were witnesses to the accident, obtain contact information from those witnesses. Once they are gone, you are unlikely to ever find them again, so this is something that needs to be done quickly.

Obtain the name, contact information, and insurance information from your Lyft driver and the other driver. Take photos of the license plates, driver's licenses, and insurance information of both drivers, since at this point it is unclear whether you will be filing a claim against the Lyft driver, Lyft, or the other driver. Once you are home after receiving medical treatment, report the accident to your own insurance company. This is important in the event that one of the drivers is uninsured or underinsured—and you carry uninsured/underinsured motorist coverage.

Write down everything you can remember about the accident. No detail is too small and could turn out to be extremely important. 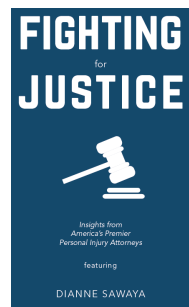
